What is e-Stamping?



- An electronic service for stamping tenancy agreements and documents for sale and purchase of immovable property without the need to present them to IRD in person.
- An alternative mode of stamping with a stamp certificate having the same legal status as the conventional stamp.

Who can use it?

- Any business holding an E-Stamp Account
- Any individual holding an eTAX Account

Online – Credit Cards or PPS

- Stamp certificates issued instantly upon receipt of stamp duty through online mode or within 2 working days after receipt of stamp duty through offline mode.
- Free online service for checking authenticity of a stamp certificate.
- One Stop Service submission of tenancy e-forms of Rating and Valuation Department online after e-Stamping of tenancy agreement.
