Except where there is an exemption provided under the Personal Data (Privacy) Ordinance (Cap. 486), you have the right to request access to and correction of your personal data. Such request should be addressed to the Business Registration Officer at 4/F, Revenue Tower, 5 Gloucester Road, Wan Chai, Hong Kong.

Important Notes

- You should submit the notification within one month from the date of admission/retirement of partner(s).
- You can use more than one copy of the form if the columns are not sufficient for completion. In that case, all the other remaining partner(s) are required to sign on each copy of the form. Please staple all the forms together and submit them for registration.
- The properly completed and signed form must be submitted together with the necessary supporting documents by post to P.O. Box 29015, Gloucester Road Post Office, Hong Kong; or in person at the Business Registration Office, 4/F, Revenue Tower, 5 Gloucester Road, Wan Chai, Hong Kong.
