附註 Notes

- (1) 有關選擇一經作出將持續有效，直至正式撤銷為止。如欲撤銷有關選擇，請於一張有效的3年商業登記證屆滿前1個月或之前向局長發出書面通知。
An election shall remain valid until such time as it is revoked. An election may be revoked by a notice in writing to the Commissioner at any time not later than 1 month before the expiry date endorsed on a valid 3-year certificate.
- (2) 你的選擇將會同時適用於業務的總行及所有分行。如你下一張登記證的生效日期是2023年1月1日，請於“生效年度”欄填上“2023”。
The election is applicable to both the main office and all branches of the business. If your next certificate commences on 1 January 2023, please state “2023” in the field of “Effective Year”.
- (3) 如你現有的登記證是於2022年12月31日屆滿，你必須於2022年11月30日或之前作出選擇。否則，你下一張由2023年1月1日開始生效的登記證仍然是一張1年有效期的登記證，而你的選擇要待再下一張由2024年1月1日開始生效的登記證才生效。如你仍欲就2023年1月1日開始生效的登記證作出逾期選擇，請說明原因〔例如：不在香港、疾病或其他合理因由〕導致你未能準時作出選擇。
If your current certificate expires on 31 December 2022, your election must be made on or before 30 November 2022. Otherwise, your next certificate commencing on 1 January 2023 would still be a 1-year certificate and your election would only be applicable to the certificate commencing on or after 1 January 2024. If you wish to pursue your late election for the certificate commencing on 1 January 2023, please state the reason (for example, absence from Hong Kong, sickness or other reasonable cause) preventing you from lodging the election on time.
- (4) 如簽署人是「法團董事」或秘書公司，必須填上其商業登記號碼。如未能提供商業登記號碼，請提交簽署人成立為法團的地方的政府發出的「公司註冊證書」。否則，請填上簽署人的身分證號碼或護照號碼。
If the signer is a “corporate director” or secretarial firm, please fill in its business registration number. In all other cases, please fill in the identity card number or passport number of the signer.

The business registration fee and levy paid will not be refunded even though the business or the branch may cease to be carried on before the expiry of the validity period of a 3-year certificate.

Personal Information Collection Statement

It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your application / notification will not be accepted.

The personal data provided by you will be used for tax and business registration purposes and may be made available for public inspection pursuant to sections 19 and 19A of the Business Registration Ordinance (Cap. 310) so as to enable any person to ascertain whether a business is registered under that ordinance and the particulars of the businesses so registered, in accordance with section 19B of that ordinance. The Department may also give some of such data to other parties authorized by law to receive it. Except where there is an exemption provided under the Personal Data (Privacy) Ordinance (Cap. 486), you have the right to request access to and correction of your personal data. Such request should be addressed to the Business Registration Officer at 2/F, Inland Revenue Centre, 5 Concorde Road, Kai Tak, Kowloon, Hong Kong.
