## 附註 Notes

- (1) 有關撤銷選擇一經作出將持續有效，直至另次有效選擇為止。請於一張有效的 3 年商業登記證屆滿前 1 個月或之前向局長發出本書面通知。  
This revocation shall remain valid until such time as a fresh valid election is made. Please give this notice to the Commissioner at any time not later than 1 month before the expiry date of a valid 3-year certificate.
- (2) 你的撤銷選擇將會同時適用於業務的總行及所有分行。如你下一張登記證的生效日期是，舉例說：2023 年 7 月 1 日，請於“生效年度”欄填上“2023”。  
The revocation is applicable to both the main office and all branches of the business. If your next certificate commences on, for example, 1 July 2023, please state “2023” in the field of “Effective Year”.
- (3) 如你現有的登記證將於，舉例說：2023 年 6 月 30 日屆滿，你必須於 2023 年 5 月 31 日或之前作出撤銷選擇。否則，你下一張由 2023 年 7 月 1 日開始生效的登記證仍然是一張 3 年有效期的登記證，而你的撤銷選擇要待再下一張由 2026 年 7 月 1 日開始生效的登記證才生效。如你仍欲就 2023 年 7 月 1 日開始生效的登記證作出逾期撤銷選擇，請說明原因〔例如：不在香港、疾病或其他合理因由〕導致你未能及時作出撤銷選擇。  
If your current certificate expires on, for example, 30 June 2023, your revocation must be made on or before 31 May 2023. Otherwise, your next certificate commencing on 1 July 2023 would still be a 3-year certificate and your revocation would only be applicable to the certificate commencing on or after 1 July 2026. If you wish to pursue your late revocation for the certificate commencing on 1 July 2023, please state the reason (for example, absence from Hong Kong, sickness or other reasonable cause) preventing you from lodging the revocation on time.

你提供的個人資料將用於稅務及商業登記用途及可供任何人士根據《商業登記條例》(第 310 章)第 19 及 19A 條查閱，以根據該條例第 19B 條確定某項業務是否已根據該條例登記及已登記的業務的詳情。本局亦可能會把部分該等資料交給法例授權接收的其他人士。除了《個人資料(私隱)條例》(第 486 章)規定的豁免範圍之外，你有權要求查閱及改正你的個人資料。有關要求應向商業登記主任提出，其地址為香港九龍啟德協調道5號稅務中心 2 樓。

### Personal Information Collection Statement

It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your application / notification will not be accepted.

The personal data provided by you will be used for tax and business registration purposes and may be made available for public inspection pursuant to sections 19 and 19A of the Business Registration Ordinance (Cap. 310) so as to enable any person to ascertain whether a business is registered under that ordinance and the particulars of the businesses so registered, in accordance with section 19B of that ordinance. The Department may also give some of such data to other parties authorized by law to receive it. Except where there is an exemption provided under the Personal Data (Privacy) Ordinance (Cap. 486), you have the right to request access to and correction of your personal data. Such request should be addressed to the Business Registration Officer at 2/F, Inland Revenue Centre, 5 Concorde Road, Kai Tak, Kowloon, Hong Kong.
