- 3. 若該有限合夥基金在註冊撤銷後繼續以合夥 的形式存在及在香港經營業務,則該合夥業 務仍須每年申領商業登記證。
- 4. 如簽署人是法人團體/有限合夥基金/有限責任合夥,則必須填上其商業登記號碼。如未能提供商業登記號碼,請提交簽署人成立為法團/有限合夥基金/有限責任合夥的地方的政府發出的註冊證明書影印本。否則,請填上簽署人的身分證號碼或護照號碼。
- 5. 此通知書須由普通合夥人、獲授權代表或投資經理簽署。獲授權代表須為依據《有限合夥基金條例》委任的獲授權代表。

你提供的個人資料將用於稅務及商業登記用途 及可供任何人士根據《商業登記條例》第310章) 第19及19A條查閱,以根據該條例第19B條確 定某項業務是否已根據該條例登記及已登記的 業務的詳情。本局亦可能會把部分該等資料交給 法例授權接收的其他人士。除了《個人資料(私 隱)條例》(第486章)規定的豁免範圍之外,你 有權要求查閱及改正你的個人資料。有關要求應 向商業登記主任提出,其地址為香港九龍啟德協 調道5號稅務中心2樓。

## 怎樣通知

- 填妥本表格或來信通知。本表格可在稅務局網頁(www.ird.gov.hk)下載。
- 將已填妥及簽署的通知書(正本)連同所須 證明文件:
  - 寄往香港九龍協調道郵政局郵箱 29015 號;或
  - 親身交回商業登記署,地址:香港九龍啟 德協調道5號稅務中心2樓。
- 請勿將表格傳真/電郵給商業登記署。

#### **Notes**

- 1. Advance notice will not be accepted.
- If there is any change in the business registration particulars or cessation of business, the business operator is required under the Business Registration Ordinance (Cap. 310) to notify the Commissioner of Inland Revenue in writing within one month of such change or cessation.
- 3. If the fund continues in existence in the form of a partnership after the deregistration and carries on business in Hong Kong, it is required for the partnership to take out a business registration certificate annually.
- 4. If the signer is a body corporate/limited partnership fund/limited partnership, please fill in its business registration number. If business registration number is not available, supply a copy of its Certificate of Incorporation/Registration issued by the relevant government authority in its place of incorporation/registration. In all other cases, please fill in the identity card number or passport number of the signer.
- 5. This notice must be signed by the general partner, authorized representative or investment manager. The authorized representative must be appointed under the Limited Partnership Fund Ordinance.

#### **Personal Information Collection Statement**

It is obligatory for you to supply the personal data as required by this form. If you fail to supply the required data, your application / notification will not be accepted.

The personal data provided by you will be used for tax and business registration purposes and may be made available for public inspection pursuant to sections 19 and 19A of the Business Registration Ordinance (Cap. 310) so as to enable any person to ascertain whether a business is registered under that ordinance and the particulars of the businesses so registered, in accordance with section 19B of that ordinance. The Department may also give some of such data to other parties authorized by law to receive it. Except where there is an exemption provided under the Personal Data (Privacy) Ordinance (Cap. 486), you have the right to request access to and correction of your personal data. Such request should be addressed to the Business Registration Officer at 2/F, Inland Revenue Centre, 5 Concorde Road, Kai Tak, Kowloon, Hong Kong.

- The properly completed and signed notification (original) must be submitted together with the necessary supporting documents:
  - by post to P.O. Box 29015, Concorde Road Post Office, Kowloon, Hong Kong; or
  - in person at the Business Registration Office, 2/F, Inland Revenue Centre, 5 Concorde Road, Kai Tak, Kowloon, Hong Kong.
