

Added Benefits

File your Tax Return - Individuals through the Internet and enjoy:

- ☑ Automatic extension of 1 month for filing;
- ☑ Pre-filling of data* including income amount details*, if applicable, to save your time in completing the tax return;
- ☑ Saving of partially completed return for further completion within 4 months; and
- ☑ Computation of your estimated Salaries Tax payable* before submission to help you optimize total tax payable.

Available for the tax return for the year of assessment 2022/23 only.
* Dependent on when the Employer's Returns are filed.

Simple Criteria

An eTAX Account holder who is required to file a tax return for 2020/21, 2021/22 or 2022/23 can file through the Internet if he / she in that year of assessment

- ☑ does not claim exemption in respect of part or all of his / her salaries income;
- ☑ does not own any sole proprietorship business with gross income of more than \$2,000,000;
- ☑ does not have any deemed assessable profits pursuant to section 20AE, 20AF, 20AX and/or 20AY of the Inland Revenue Ordinance;
- ☑ has not obtained an advance ruling on any of his / her tax matter in relation to that year; and
- ☑ does not claim any double taxation relief pursuant to an arrangement specified under section 49(1) or 49(1A) of the Inland Revenue Ordinance in relation to that year.

Easy Steps

Step 1 Read Important Notes

Step 2 Complete the Tax Return

Check the pre-filled data and update/fill in relevant parts of the tax return requiring completion.

Step 3 Sign and Submit

Check accuracy of data before signing the tax return by eTAX Password, MyGovHK Password, digital certificate or "iAM Smart" account with digital signing function.

Step 4 Acknowledgement

Quick Save and Retrieval

- ☑ Click the **Save & Quit** button to save the data which will be retained for 4 months
- ☑ Follow filing procedures to retrieve your return for completion

- ☑ You can view the return and the estimated Salaries Tax computation in the Tax Position section instantly after submission
