The purpose of issuing copies of business registration documents and/or extracts of information on the Business Register is to enable any person to ascertain whether a business is registered under the Business Registration Ordinance (Cap. 310) and the particulars of the businesses so registered, in accordance with section 19B of that ordinance ("Public Search Purpose").

Any person accessing or obtaining information on the Business Register shall comply with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486) in respect of the use of personal data and shall not use such personal data for any purposes other than the Public Search Purpose or any purposes not directly related to the Public Search Purpose.
